## **III. DESCRIPTION OF FINDINGS & CONCLUSIONS**

#### A. Physical Description of Facility

This YMCA day camp is in Ann Arbor Township within Washtenaw County. This camp begins and ends each day at the Metropolitan YMCA, the building features a natatorium, gymnasium, playground, and studio space(s). Camp will utilize designated spaces within the Y, and explore Ann Arbor's greenspaces Virginia and West Park, The Farmers' Market, and University of Michigan Diag. This day camp is less than one mile from downtown Ann Arbor and within seven minutes of Mott's Children's Hospital.

### **B.** Program Description

YMCA day camp offers a variety of specialty, sports and traditional summer camp programs. Camp activities include swimming, campcrafts, cooking, sports, gymnastics, dance, music, canoeing, nature and off-site field trips. The campers are supervised by trained adult staff with some minor staff for support. Staff are trained in proper behavior management, camper supervision, child abuse prevention, program planning and implementation, CPR and First Aid, and YMCA policies and procedures. Plans for emergencies, rain, and regular camp operations meet licensing rule compliance.

### C. Rule/Statutory Violations

The camp Site and Program are in substantial compliance with applicable statutes and administrative rules.

## IV. RECOMMENDATION

I recommend issuance of a provisional Program and Site license to this child day camp.
