## IV. Description of Findings and Conclusions

On 3/3/25, the department received a written request from City of Detroit, program manager, Lauren Wright to modify the capacity terms of the children's camp and campsite licenses. Ms. Wright wrote a general request for increasing capacity for multiple facilities and changing age group terms at some of the facilities.

On 4/8/25, I conducted an onsite inspection at the camp facility with Ms. Wright. The building is a Detroit Parks and Recreation Center used for community recreation programs. The facilities include a city owned park and large community center building. Ms. Wright identified the designated spaces for the children's camp indoor shelter as the "ice arena" (23000sq/ft). The facility has indoor bathrooms available to support the capacity increase. The outdoor space includes 18 acres park with a large pavilion, playground, outdoor track, ball field, basketball courts, and open fields for activities. The camp facilities, including indoor, outdoor, and bathrooms support the capacity of 45 campers.

#### V. Recommendation

I recommend the capacity terms be modified from 45 campers to 75 campers.
